**TAX LEVY ELECTION
PAPIO-MISSOURI RIVER
NATURAL RESOURCES DISTRICT
IN THE STATE OF NEBRASKA**

Shall the Papio-Missouri River Natural Resources District, upon approval by a 2/3 vote of its Board of Directors as provided by law, be authorized to issue Flood Protection and Water Quality Enhancement Bonds for the purpose of paying costs of design, right of way acquisition and construction of multipurpose projects and practices for storm water management, including flood control and water quality, such bonds to be issued and sold in one or more series from time to time, to bear interest at such rate or rates, and to become due at such time or times as may be determined by the Board of Directors; and

Shall the Papio-Missouri River Natural Resources District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District for the purposes of paying principal and interest on such bonds, which tax levy may exceed the statutory bond levy limit of one cent on each one hundred dollars of taxable valuation within the District by an amount up to an additional one cent, but which shall be included within the overall statutory tax levy limit for the District?

Electors voting in favor of said proposition shall blacken the oval opposite the words "FOR such bonds and tax" following said proposition, and electors voting against said proposition shall blacken the oval opposite the words "AGAINST such bonds and tax" following said proposition.

**SCHOOL BOND ELECTION
WASHINGTON COUNTY
SCHOOL DISTRICT 0001
(BLAIR COMMUNITY SCHOOLS)
IN THE STATE OF NEBRASKA**

"Shall Washington County School District 0001 (Blair Community Schools) in the State of Nebraska (the "District") issue general obligation bonds of the District in the stated principal amount not to exceed Nineteen Million Six Hundred and Thirty Five Thousand Dollars (\$19,635,000), for the purpose of paying the costs of renovations, improvements, and construction for the District's facilities, including but not limited to, building and

site infrastructure, HVAC and building systems, replacement and repair of roofs, upgrades to safety and security systems, improvements to classroom, recreation, parking, transportation and sports facilities, and providing the necessary furniture, equipment, and apparatus for such school building additions, renovations and construction; such bonds to be issued and sold from time to time on such terms as may be determined by the Board of Education, to bear interest at a rate or rates to be determined by the Board of Education and to become due at such time or times as may be fixed by the Board of Education; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?"

Pursuant to §32-912 N.R.S. a registered voter who is not affiliated with a political party and who desires to vote in the primary election for office of U.S. House of Representatives may request a partisan ballot for such office from any political party.
